Howdy, ASP! One of the main tasks of the President Elect is to chair the Priorities and Planning Committee. Over the last few years I've been keeping notes when someone suggests a change we should make at ASP, and I'll be presenting the list I've come up with at our committee meetings.

Here are some things we'll be discussing:

The by-laws committee started suggesting changes to our by-laws last year. Some potential changes to consider this year include updating how folks are picked for the Nominating and Tellers Committee. Everyone on this committee turns over every year, and it seems desirable to have longer, staggered terms. For example, maybe only half of the nominating committee is switched out every year. This way there will be more institutional memory, which will hopefully make the Committee's tasks easier overall. Also, President Choudhury has suggested ASP



consider reworking our current system where a member transitions from Vice President to President Elect to President to Immediate Past President. Anindo has proposed we instead have a system where someone is President for two years. So, for example, maybe we would have someone be Vice President for two years, and then be President

for two years. They would still serve for 4 years, but would have 2 years to carry out any plans they have for the Society. This additional time to become familiar with the position and achieve goals may make the President more effective overall.

- President Choudhury has re-instated the Investment Committee, for which I'm the Chair. We'll be looking over our various funds and restrictions associated with these funds to see if we can get more money going to our student members for research projects and to offset travel to our meetings. We're also going to look to see if any funds can be used to start new initiatives as well.
- We're going to look at the Lectureships offered by our society currently, and see if we can modify them slightly to better appeal to the current interests of our membership. This may depend on stipulations made when the funds for these Lectureships were established, which is something that we'll look into.
- At the Student Business Meeting in Winston-Salem the students recommended we start offering an award to recognize excellence in outreach and broader impacts. And over the years various folks have also suggested we begin a program to name Fellows of the Society. So we'll chat about the current state of our awards.

Regarding Membership, Mike Moser has recommended we consider more ways to retain Early Career Researchers, and Jillian Detwiler has suggested we think of ways to attract scientists working in government or NGOs.

These are just some topics we'll be discussing. Nothing has changed yet, and all changes to the by-laws need to be sent to the whole society and then voted on prior to going into effect. 

Each year the ASP gives several awards at the Annual Meeting. It is important that the committees involved receive nominations and supporting materials early in the annual meeting cycle to be able to process the materials in a timely manner. The awards listed below are those which have been established for 2026. Nominations and all supporting materials should be submitted to the respective chairs of these committees as listed. 2026 Henry Baldwin Ward Award

Nominations will close on January 23, 2026.

Eligibility: The recipient shall be a member of the Society for no less than three years at the time of the nomination, be in mid-career, and who, by self-directed investigations, will have attained a position of leadership in some phase of parasitological research. The field of parasitology is considered to include, in general, those aspects of the science which are represented by reports published in the official organ of the Society, The Journal of Parasitology

Nominations: The award is given to an outstanding scientist in midcareer who has attained a position of leadership in some phase of parasitological research.

Nominations for the Henry Baldwin Ward Medal should be supported by adequate documentation to enable the Awards Committee to exercise critical evaluation. At the least, this documentation should consist of: (a) a complete curriculum vitae providing a bibliography in which the authors are listed in the same sequence as in the published papers, and (b) three supporting letters, including the original nominating letter. These letters should include a serious evaluation of the major aspects of the nominee's scientific work.

Award: The award consists of travel and accommodation expenses, an honorarium, a certificate, and the bronze Ward Medal presented at the Annual Meeting of the Society. The recipient will be expected to deliver a 45-minute acceptance speech.

2026 Ashton Cuckler New Investigator Award

Nominations will close on January 23, 2026.

Eligibility: The award is given to a new investigator who has, within the last two years, been awarded a Master or Doctoral degree in the field of Parasitology. Selection will be based upon the body of research accomplished during the candidate's graduate studies. This "body of research" will be documented through: a) peer-reviewed journal or book publications directly related to research conducted in pursuit of and contained in the accepted graduate student thesis or dissertation, b) other peer-reviewed journal publications unrelated to the primary thesis or dissertation work, but derived from research conducted as a graduate student, c) papers and/or posters presented at scientific meetings as a graduate student, d) any outside recognition of research excellence which may include, but not be restricted to, best student paper awards, dissertation improvement grants, student-initiated research grant support, and the like.

Nominations: Nominations must be made within two years following awarding of the Master or Doctoral degree, and the nominee must be a member of the ASP at the time the award is made. Required documentation for award consideration should include:

- A nominating letter by the student's graduate advisor critically evaluating the quality and significance of the student's research. (Note: the advisor must be a member of ASP at the time of nomination.)
- Two letters of support from noted authorities outside of the nominee's institution commenting on the significance of the body of research accomplishments. The advisor will submit the name of one evaluator and the second will be chosen by the Awards Committee.
- The nominee will provide the following documentation: i) letter providing a self-evaluation of research accomplishments; ii) thesis/dissertation abstract (two-page limit); iii) curriculum vitae; and iv) reprints or copies of all research publications (published or in press).

Award: The award will consist of travel and accommodation expenses, a cash honorarium, and a plaque to be presented during the Annual Meeting of the Society.

2026 Clark P. Read Mentor Award

Nominations will close on January 23, 2026.

Eligibility: The award honors an individual who, during his or her career, has demonstrated extraordinary leadership in the training of young scientists who have successfully pursued the independent study of parasites or aspects of the host-parasite relationship. Further, the individual shall have influenced the research and/or graduate education of a department, college, or institution to significantly increase the number of students completing graduate level training in the various disciplines of parasitology.

The selection criteria for the Clark P. Read Mentor Award include, but are not limited to, two or more of the following:

- evidence of scholarship in research and graduate education;
- evidence of success of graduates or postdoctoral trainees;
- innovative teaching methods;
- innovative or unique aspects of bench training;

- letters of support;
- the award should be for individuals who have made documentable impact on the field of parasitology through their didactic and/or bench-level teaching, or through furthering scientific literacy;
- nominations from ASP members or the selection committee's initiative to put forth a name will be acceptable
- candidates for the award must be a member of ASP, at least by the time the award is given.

Nomination: The nomination package for the Clark P. Read Mentor Award should include the following:

- Letter of nomination
- Current Curriculum Vitae
- List of current and former students mentored and, if known, their present position/status including:
 - Undergraduate students
 - Graduate students
 - Post-doctoral trainees
 - Students on whose thesis/dissertation committee the nominee served
- Letters of Support (minimum of 4) that speak to the nominee's strengths as a mentor.
 - Former/current students: Letters of support from former/current students should focus on firsthand evidence of the "mentorship" abilities of the nominee.
 Colleagues: In addition to commenting on evidence of
 - Colleagues: In addition to commenting on evidence of scholarship in research and publication, it is important that the individual writing the letter comment on the nominee's interaction with and influence on students in a mentorship capacity.

Award: The award will consist of travel and accommodation expenses, a cash honorarium, and a plaque to be presented during the Annual Meeting of the Society. The recipient will be expected to deliver a 20-minute oral presentation to the membership of the Society emphasizing his or her views and experiences related to mentoring.

2026 Eminent Parasitologist Lectureship

Eligibility: The Eminent Parasitologist Lectureship Award is presented by the ASP to honor someone who exhibits eminence and international visibility for a substantial contribution to the field of Parasitology over a significant period of time. Nominees should have established international recognition for substantial contributions to basic scientific research that has impacted the field of Parasitology. Eligibility is not limited to ASP members.

Nomination: Nominations may be received from any member of the ASP and will consist of a primary nomination and a minimum of two second nominations. The primary nominator will submit the candidate's Curriculum Vitae, plus a summary outlining the candidate's contributions to the enhancement of research on parasites. Those seconding a nomination must submit supporting letters that include a serious evaluation of major aspects of the nominee's scientific work.

Award: The award will consist of travel and accommodation expenses, a cash honorarium, and a plaque to be presented during the Annual Meeting of the Society. The recipient will be expected to deliver a 50-minute major address to the membership of the Society.

Regional Society Updates

Helminthological Society of Washington

We're thrilled to announce that our 2025 Anniversary Award recipient is Dr. Anna Phillips! We celebrated Anna's accomplishments and contributions to HelmSoc at our fall meeting on Saturday, November 8th at Founding Farmers in Reston, VA.

Here is what the Anniversary Award Committee had to say about Dr. Phillips' contributions:

The Helminthological Society of Washington's Anniversary Award Committee (Ashleigh Smythe, Florian Reyda, and Autumn Smith-Herron) nominates Dr. Anna J. Phillips for the 2025 Anniversary Award. Dr. Phillips is a Research Zoologist and Curator of Parasitic Worms at the Smithsonian's National Museum of Natural History (NMNH) in Washington, DC. She is an expert on the evolution, taxonomy, and biogeography of cestodes, leeches, and leech relatives. She has made scientific contributions on a wide variety of additional parasites as well. Dr. Phillips has studied leeches from genera such as Placobdella. Macrobdella. Mesobdella. and Haementeria. She has conducted research on a diversity of other annelids as well, including Branchiobdellida and earthworms (Eudrilus). She has published on cestodes of South American birds (Anonchotaenia and Cucolepis) and mammals from around the word (Spirometra). Further, she has published on sucking lice (Hoplopleura), parasitic copepods (Shiinoidae), and microbial and eukaryotic symbionts of parasites. Dr. Phillips' contributions have ranged in scale from the detailed morphology of leeches, to reviews on parasite biodiversity and the importance of parasite collections.

A profound commitment to the US National Parasite Collection (USNPC) also highlights Dr. Phillips' importance to the community of parasitologists worldwide. She was the lead curator managing the transfer of the USNPC from the USDA – Animal Research Service in Beltsville, MD to the NMNH, including over 85,000 specimen lots and 7,000 type series. Dr. Phillips maintains curatorial oversight of the collection, and has acquired over \$500,000 in grant funding for its maintenance and improvement.

Dr. Phillips has also greatly contributed to the field of parasitology through her outstanding mentorship. While she is not part of a degree-granting institution, she has been pivotal in the scientific development of numerous young scientists, in particular women, ranging from high school, undergraduate, MS, and PhD students to postdoctoral fellows. Dr. Phillips has hosted over 15 high school and undergraduate students and over 15 graduate students doing research in her lab at the National Museum of Natural History. One example that stands out was her hosting an MS student, Maggie Doolin, for 2 summers at the National Museum of Natural History. Dr. Doolin recently finished her PhD, and Dr. Phillips' mentoring played no small part in Dr. Doolin's success.

Finally, Dr. Phillip's contributions to the Helminthological Society of Washington are also deep and diverse. She joined the Society in 2013, and was an Executive Committee Member from 2016 through 2021, serving as the Recording Secretary. She also served on the Membership Committee from 2013 until 2018, the Student Awards Committee in 2015, and the Meeting Site Organizing Committee in 2016. The Society has benefited greatly from Dr. Phillips' continued wisdom and measured input on managing the Society and its journal, Comparative Parasitology.

For her outstanding contributions and service to the field of parasitology and to the Helminthological Society of Washington, the Anniversary Award Committee heartily nominates Dr. Anna J. Phillips for the 2025 Anniversary Award.

The student paper competition was competitive, with the Marc H. Dresden Award presented to Sam Messinides (Arkansas State University), the David A. Becker Award presented to Alex Bell (Angelo State University) and honorable mentions for oral presentation awarded to Sydnie McMahan (University of Kansas) and Takuma Shiina (University of New Mexico). Jasmine Sevilla-Mchargue (Sam Houston State University) and Alexis Hernandez (Sam Houston State University) were awarded for excellence in poster presentation. Research grants were awarded to Allison Bryant (Oklahoma State University) and Julia Pye (Arkansas State University).

The Society acknowledged Debra Clopton (Peru State College) for her service as 2024–2025 president, and welcomed Joseph Fauver (University of Nebraska Medical Center) as 2025–2026 president and Kyle Gustafson (Arkansas State University) as president-elect. Joanna Cielocha (Rockhurst University) serves as the Secretary-Treasurer and Kaylee Herzog (University of Nebraska Medical Center) serves as the representative to the ASP.

Looking forward, the membership voted to return the 2026 meeting to the society's traditional meeting location, the University of
